# 20th Anniversary of National Language and Script Day

Language and Script Day is celebrated on the first Sunday of May, of each year as per Presidential Decree in 2003 and the Day was widely marked this year for its 20th anniversary.

head of the Day, "Mongolian Script-2025," a special exhibition took place at the Chinggis Khaan Museum to report the works done for the preparation of the implementation of the Law on the Mongolian language, which stipulates conducting official affairs in dual script: Mongol script and Cyrillic

The works showcasing the successful completion of 69 projects to accomplish the four phiertypes of the Table 1 objectives of the Traditional Mongol Script Program-3 were displayed in the exhibition. Under the preparation, 141 thousand public servants of 4500 public organizations in 21 aimags, 330 soums were assessed for Mongol script testing. A survey shows that 53.6 percent of all public servants defined themselves as prepared for day-to-day use of the Mongol Script. 460 teachers have been trained on a national level to teach Mongolian script to public servants at Government organizations and is continuing to advance the digital writing usage of Mongol script through handbooks and training. In addition, a series of 20 Mongol script through the series of 20 Mongol script through golian writing lessons for public servants, developed in collaboration with skilled teachers of Mongol Script will soon air on the Mongolian National Broad-



casting. The Ministry of Digital Development and Communications is developing Technical Rules for the Unicode Standard of the Mongol Script and Rules for Unicode Standard of the Mongol Script's Character Converter to advance the Mongol Script Unicode standard.

'In the future, we will develop an educational application for Mongol Script to educate the public through distant learning.

Moreover, the Government will evaluate public servants know-ledge of Mongol Script not only through a single test but also by completing their level of advancement by enrolling in beginner, intermediate, and advanced level courses," said Minister of Education and Science Mr. Enkhamentary Amgalan.

Currently, more than 20 websites, 8 online dictionaries, more than 80 Facebook groups, pages, and Instagram pages have been created in Mongol script and the number of active members have reached 570,000.

The newspaper "Humuun Bichig," published by MONTSAME, the Mongolian National News Agency, employee name cards printed according to the government standard, official letters written in the Mongol script, Mongol Script dictionaries, diplomas and certificates issued

by educational institutions of all levels in both Cyrillic and Mongol script were displayed at the exhibition. Moreover, the works of P. Erhembayar, which were inscribed in Mongol script on natural stones, and crafted using colored metal that was hammered using the traditional Mongolian iron bar technique, have been adorned with gold plating and

# **Ethics of Public Servants on Focus for Combating Corruption**

All High-Ranking Officials to be Prohibited from Participation in Government Procurement

The State Great Khural has recently approved the Law on Ethics of Public servants and now discussing the draft amendment to the Law on Regulation of Public and Private Interests and Prevention of Conflict of Interest in Public Service. These laws are considered as cornerstone of the efforts to combat corruption.

the 10th of May, 2023, the Chairman of the State Great Khural, G. Zandanshatar, addressed a gathering of employees from the local administration organizations of the capital city where he remarked that the Law on Ethics of public servants would be the cornerstone of the efforts to combat corruption. The Chairman emphasized the importance of ethics in law



and cited an ancient proverb that states that "if a thousand laws are made, they would not be obeyed without ethics". He stressed the need for following ethical norms at all levels to establish social justice, highlighting the crucial

roles of an Ethics Council to be established under each public organization and the Ethics Committee to be operated under the Public Service Council to play in implementing the law.

The law, which comprises

seven chapters and nineteen articles, applies to a total of 225,205 employees of 4,232 public organizations, 103 stateowned and local-owned legal entities, and 103 authorized officials of companies with the state-owned and local-owned legal entities. Additionally, legal entities. Additionally, the law is applicable to 8,928 members of the Citizens Representative Meeting and general directors of the National Council of Radio and Television, n, members of the supervisory board, and senior officials of NGOs that receive funding from the state and local budgets and perform certain government functions in accordance with the law. In total, the law will affect 234,251 employees.

#### Minister of Education and Science Attends EWF



Mongolian delegation led by Minister of Education and Science L. Enkh-Amgalan took part in the "Education World Forum," which was held in the United Kingdom of Great Britain and Northern Ireland on May 7-10.

t the Forum, Minister of Education and Science L. Enkh-Amgalan delivered a presentation on reforms and policies pursued by the Government of Mongolia in the education sector.

The general enrollment rate for kindergarten and school is 90-98 percent in Mongolia, considerably high in the world. So, rather than accessibility, quality reform will be the focus of education policy in Mongolia in the future, according to his presentation. Moreover, the Minister highlighted the principle, to which the Government of Mongolia adheres, that the school close to home should be the best.

Another point, emphasized in the presentation of the Minister, was the teaching quality and performance evaluation which had been conducted in urban and rural area schools to determine the gaps between them. This evaluation has unveiled many opportunities to enhance the management of schools, improve the knowledge and skills of the teachers in the workplace, and introduce a financial system based on performance and work results. Most importantly, it will provide equal learning opportunities for all students regardless of their location through digital learning platforms.

On the sideline of the Forum, Minister Enkh-Amgalan met the Minister of Technical Education, Vocational Training, Employment, and Labor of the Republic of Guinea, the Minister of Higher Education and Scientific Research of Libya, and a knowledge analyst at McKinsey, a Silicon Valley company. During the meetings, the parties exchanged views on the role of education in sustainable development.

### Mongolia to Participate in PISA-2025 Assessment

On the sideline of the Forum, the Minister met Andreas Schleicher, the Director for Education and Skills, Organization for Economic Cooperation and Development (OECD), and expressed an intention to participate in PISA-2025.

In 2022, 88 countries were involved in the PISA assessment, and as for our country, 9600 students from 196 schools were assessed. The assessment report will be published in December.

PISA is the OECD's Program for International Student Assessment. PISA measures 15-year-olds' ability to use their reading, mathematics, and science know-ledge and skills to meet real-life challenges. Results from PISA indicate the quality and equity of learning of the countries involved



and allow educators and policymakers to learn from the policies and practices applied in other countries.

#### Request Put Forth to Increase Number of Students Involved in **Chevening Scholarship**

During the Education World Forum-2023, Minister of Education and Science L. Enkh-Amgalan met Andrew Mitchell, the MP and Minister of State at the Foreign Office (Minister for Development), and Gillian Keegan, the Secretary of State for Education of the United Kingdom of Great Britain and Northern Ireland.



At the onset of the meeting, the parexchanged congratulations on the 60th anniversary of the establishment of diplomatic relations between the two countries and exchanged views on cooperation in the education sector, with a particular focus on increasing the number of students to be involved in the Chevening scholarship. Chevening scholarship has been open for Mongolian students since 1993. Every year, up to 10 students receive the Chevening scholarship from Mongolia. As of today, about 200 Mongolian students have studied in the UK with this scholarship.



# Top Taxpayers Announced

Taxation organizations collected MNT 9.3 trillion to the state and local budgets, exceeding by MNT 1.1 trillion the planned MNT 8.2 trillion, according to the 2022 Financial Report.

Head of General Department of Taxation B. Zayabal announced that tax revenue of MNT 10.1 trillion would be collected to the state budget in 2023 at the opening of the annual Taxpayers' Days on May 8.

performance shows that companies and enterprises engaged in mining, processing, financial and insurance sectors paid the most taxes.

Overseas and domestic operations of the Mongolian tax organizations have been fully transitioned to the digital form. This year's Taxpayers' Days will be celebrated under the slogan "Let's have service digitally," said Head of the General Department of Taxation B. Zayabal.

According to the tax revenue performance data for the first four months of this year, the tax revenue increased by MNT 1.5 trillion compared to the same period of the last year. The budget stimate also exceeded by some MNT 1 trillion. This is directly

related to the recovery of the mining industry and the volume of exports.

As for VAT revenue, internationally it accounts for 30-35 percent of the total budget revenue. In the countries of the European Union, it makes 33-34 percent while in Mongolia, 24-27 percent of the total budget revenue is generated from VAT revenue. Last year, MNT 1.7 trillion was collected only from VAT. Approximately MNT 257 billion was spent on the two percent VAT refunds, some MNT 10 billion were allocated for prizes and lotteries, totaling MNT 270 billion.

While previously the General Department of Taxation used to announce the 10 biggest taxpayers, since last year, it started to

select the top 10 taxpayers in four categories, dividing taxpayers into the following four segments:

•900 enterprises in the large segment,

•300 enterprises in the me-

dium segment,
•30 thousand enterprises the small segment,

•150,000 enterprises in the

micro segment.

# Chongqing to Cooperate in Development Projects of Ulaanbaatar

Chongqing, one of the major cities of China, the center of car manufacturing, technology, and finance in the country, has agreed to cooperate in the development projects of Ulaanbaatar On May 8. "Ulaanbaatar City Development Corporation" JSC and Chongaing Federation of Industry and Commerce signed a Memorandum of Understanding on Cooperation.

General Manager of Chong-qing Qianyi Trading Co., LTD Li Wenjun informed that they would supply the required equipment and machinery for public utilities of Ulaanbaatar. The Chinese side will provide necessary finan-cial support for leasing and purchasing equipment.

'We will renew the city and public utility fleet of auto vehicles and machinery in the frame of this cooperation. The essence is to carry out this work in cooperation with foreign and domestic businesses and investors without loading the burden on the budget. Such an opportunity opens today," said Executive Director of Ulaanbaatar City Development Corporation N. Bayarchimeg." A working group will draw up a plan for seeking financial sources based on the Memorandum. Since it is not possible to settle the financing for the modernization of the equipment of public utilities and other sectors of the city with the city budget, we proposed the member companies of the Chongqing Federation of Industry and Commerce supply

Chongqing is one of the four cities of the country under direct administration of Government of China. It the the Government of China. highly-developed industrial, financial, and technological center. There are prospects of cooperating with Chongqing as the city of green production and its equipment is manufactured incorporating leading technologies and smart solutions. The Governor of Ulaanbaatar visited this city and agreed to cooperate in the areas of supporting investment and economic development of Ulaanbaatar.

Vice Chairman of Chongqing Federation of Industry and Commerce Hong Zhongjin emphasized, "Our cooperation is starting grounded on the brotherly



relationship between Ulaanbaatar and Chongqing, as well as the visit of Mayor of Ulaanbaatar D. Sumiyabazar to Chongqing in February this year." He informed

that they would supply water sprinklers, cleaning machines required for Ulaanbaatar public utility, and electric buses for public transportation.

# **Electricity Tariff Twice Cheaper than Its Cost**

The cost of electricity is currently MNT 224 per kWh and it is sold to consumers for an average of MNT 211-213. Household consumers purchase one kWh of electricity for MNT 141-142. This is 58 percent lower than the actual cost. As for heating energy, consumers pay 55 percent lower than its cost; loss is proportionate. Last year the energy sector's operating loss amounted to MNT 187 billion.

Chairman of the Executive Office of the Energy Regulatory Commission B. Bolor-Erdene informed journalists about the real



consumption, and demand of electricity in Mongolia.

The losses are increasing. This

leads to such risks as an increase in debts, inability to carry out ne-cessary maintenance and repair at thermal power stations and heating and electricity networks, and delay of equipment renewal.

This situation will negatively affect the reliable supply of electricity and heat to consumers. The urgent need to bring the price of energy to its real cost is obvious. However, electricity consumption in 2022 has increased by 5.8 percent from the previous year amounting to MNT 10.3 billion nationwide. Out of total power, 79 percent is produced domestically, and 21 percent is imported. Here,

electricity from Russia and China

To build a new energy source, tariffs must be approved according to the Energy Law. If the price is lower than the cost, it will inevitably affect on investors. Therefore, tariffs should be kept at a level that supports and satisfies investment.

Consumers really need to save electricity, in particular, during peak hours. In general, the Law on Energy Conservation defines responsible consumers who are obliged to save energy. To be clear, the threshold of their electricity saving has been updated by the Government's resolution this year. There are some 330,000 users who have such an obligation. They consume

40 percent of the total energy. Law specifies that responsible consumers should have an energy efficiency manager. These managers promote, coordinate and implement ways to save energy. In addition, the Energy Audit Organization is operative

In total, there are 812,000 consumers electricity some 450,000 heat consumers nationwide.

There are 114 auditors engaged in energy saving, advising consumers on electricity effi-ciency, conducting audits, and determining causes of energy loss. The Commission aims to bring the auditors to the international level through training and implementing relevant projects and

# "Cultural Revival" Countrywide Campaign Launched



The Ministry of Culture has launched the "Cultural Revival" Campaign, in line with the State policy on Culture and a goal of strengthening national common values, which included in "Vision-2050", Mongolia's long-term development policy, and ensuring the implementation of laws on culture.

The State's policy on having common values and being unified with its culture and tradition has been reinforced, and cultural issues are deeply reflected in the policy decisions

of the President, the State Great Khural, and the Government of Mongolia. Mongolia's long-term development policy is swiftly advancing to build a deep sense of national identity and common values that will bolster the building of a nation with immunity.

In 2020 the Government of

In 2020 the Government of Mongolia made a historic decision to establish the Ministry of Culture independently after more than 20 years to implement the cultural policy-a pillar of the nation. Despite the Ministry of Culture's relatively short existence compared to other government bodies, in the past three years the Ministry has completely reformed the legal environment and defined policies that align with global cultural policies while reflecting the unique characteristics of Mongolian culture.

Several key laws, including Law on Culture, Law on Protection of Cultural Heritage, Law on Museums, and Law on the Support of Film Art, have been approved in the past. The Ministry has also submitted a draft Law on the Development of Creative Cultural Production to

the Parliament. The comprehensive Policy on Creative Cultural Production is deeply linked with global cultural policies and underscores the cultural sector not only as a vital component of the country's intellectual assets but also the economy.

The role and scope of the cultural sector are no longer limited to cultural and arts events. It has been fully recognized within the legal framework that culture is not only a factor of the country's independence but also intellectually and economically an essential and independent sector.

The "Cultural Revival" campaign is set to take place across Ulaanbaatar city, all the 21 Aimags, 330 Soums, and 15 Tosgons in the months of May, June, August, and October. It is worth noting that this campaign extends beyond cultural and arts performances, as national and local cultural and art organizations will showcase their endeavors in protecting cultural heritage, improving universal access to cultural education, advancing cultural tourism, and promoting creative cultural pro-

duction. Notably, public art workers and employees in urban and rural areas will partake, while citizens will engage in cultural activities.

### Programs of Non-Formal Education through Culture

As an integral part of the "Cultural Revival" campaign, a range of cultural education programs took place at Tuv aimag Public Library and "Humuun Tsogtsolbor" Secondary School on May 8.

According to the Law on Museums, a museum is mandated to organize educational and informative activities, and children under the age of 16 are allowed free entry into a museum. By virtue of this nationwide initiative, general education students

Unurbayan, a Doctor of Linguistics and Mongolia's People's Teacher, conveyed his thoughts by stating that Mongols have been recognized as one of the three prominent knowledgeable nations in the East since ancient times. Therefore, it is crucial for Mongolians to take responsibility for preserving, developing, and disseminating their language and culture. In the current era of globalization, there is an extreme tendency to prioritize the language and culture of one's own nation over that of foreign nations. As Mongolians are a small nation, we must give a precedence to our native language and culture and avoid subjugating them to the language and culture of globalization. Mongolia is the center of Mongolians worldwide; hence, safeguarding our native language culture is paramount. To survive, Mongolians must respect



own national language, script and culture and fulfill the obligation of passing them on to future generations. Children must be taught their national heritage-language at a young age, preferably at the family level, before learning foreign language. Foreign languages should not take precedence over national language and culture as they are the fundamental components of maintaining national immunity. Professor Ts. Unurbayan shared his view that if Mongolians prioritize foreign language and culture over their own, they will run the risk of losing their language and culture.

# Reducing Traffic Congestion in Ulaanbaatar with RFID System



Digitalization and Smart technologies can play a crucial role in tackling the issues that

Ulaanbaatar city is facing. As 50 percent of the total population of Mongolia resides in the capital

city, Ulaanbaatar is grappling with numerous challenges, such as air pollution, traffic congestion, and inadequate infrastructure.

The Capital City Department of Digital Development and Information Technology has been developing a unified transport system to be the next E-Mongolia of the road sector. The objective is to improve the registration and monitoring process of 654 thousand vehicles in Ulaanbaatar by utilizing the RFID system. Currently, 161 RFID antennas have been installed throughout the capital city and the system is expected to significantly improve

the detection of traffic violations.

Moreover, a live traffic map is slated to be launched this year. This Map will show real-time traffic information, including public transportation, the location, and route of child buses, traffic congestion, and available parking spaces. Dissimilar to existing systems like Google Maps and SmartBus, the information will be presented in extensive detail on the Map, enabling passengers to plan their entire route in advance, beginning with selecting the type of vehicle.

Chairman of the Standing Committee on Innovation and

Digital Policy of the State Great Khural E. Batshugar recently has worked in the Capital City Department of Digital Development and Information Technology and he highlighted the importance of using an RFID system to effectively manage traffic and reduce congestion. The Chairman also stated that the Standing Committee on Innovation and Digital Policy would actively collaborate for creating Smart-Ulaanbaatar and leveraging ongoing efforts and introducing advanced technologies with policy and legal support

# **Mongolia-Korea Forum of Tour Operators**

Forum of tour operators of Mongolia and the Republic of Korea was held last weekend at the Corporate Convention Center. Representatives of some 90 tourism companies from South Korea had tet-a-tet meetings with their Mongolian counterparts.

# **Ethics of Public Servants on Focus for Combating Corruption**

Civil servants have a duty to uphold a high standard of professionalism and ethical conduct. This includes prioritizing citizens' requests and responding within the bounds of their legal obligations. Additionally, public servants are expected to comply with dress codes approved by authorities, refrain from using inappropriate language or actions that reference the characteristics of others' body parts, avoid imi-tating the self-expression of tating the self-expression of disabled persons, and abstain from using obscene words or expressions. Furthermore, public servants are expected to respect and accurately convey opinions, and refrain from spreading false information in any form. By fulfilling these obligations, public servants can ensure that they act in the best interests of the public and maintain the integrity of their respective organizations.

In addition to these existing obligations, new obligations have been introduced. Public servants are expected not to take any actions against the reputation of Mongolia and not to use the official name for personal purposes. Adherence to these obligations is paramount in maintaining the trust and confidence of the public and upholding the integrity of the public service sector.

As a public servant, it is strictly forbidden to engage in or incite others to restrict civil rights and freedoms established by law, whether through speech or actions. It is also prohibited for public servants to involve officials under their command in political activities, to divulge personal information about a proposed individual to others, to discredit said individual, to intentionally withhold information pertinent



to official duties, or to influence management decision-making processes by providing inaccurate or incomplete information or explanations.

In accordance with the newly enacted law, regulations will be established, and it has been mandated that the Ethics Committee's opinion besought in this process. The Ethics Committee will work under the Public Service Council and have 9 members.

Prime Minister of Mongolia L. Oyun-Erdene presented the draft amendment to the Law on Regulation of Public and Private Interests and Prevention of Conflict of Interest in Public Service and addressed the Parliament session on May 4.

"As we gather today, we are reminded of our historical responsibility to rebuild trust in Government and by protecting the reputation of the fundamental pillars of democratic governance—the legislative, executive, and judiciary powers. It is our duty to put an end to the mistakes and corruption of the past 30 years, to respect the interests of the people,

to truly fulfill the right of citizen representation, and to usher in a new era of ethical leadership for the next 30 years.

We, as members of State Great Khural, belong to the people, and we must lead by example. Ethical, disciplined, and responsible leadership should begin with us, in this hall. If we cannot hold ourselves to the highest standards, how can we ask government officials and citizens to strictly follow the adopted laws and regulations?

The Government of Mongolia has declared 2023 as the "Year to Combat Corruption." This includes exposing corruption crimes through "whistleblow" operation, wiping "parasites" from public offices through "wipeout" operation, and bringing back overseas escapers through "Wasp" operation. The "5W" Campaign has also been implemented to "transfer" illegal funds hidden in offshore areas and foreign countries to ensure the transparency of Government institutions.

It is clear that the giant oak tree of systemic corruption,

which have been rooted deep into the soil, will not collapse in the blink of an eye. Those who benefit from corruption will do everything in their power to protect their interests, by using false information and creating an organized system to protect against theft. We must be vigilant and persevere in the fight against corruption.

As information becomes more transparent and citizens become more informed, the corruption system will continue to crumble. We must do what is right, and the truth will prevail. This is the advantage of Democratic Government.

Upon the passage of this law, all high-ranking Government offi-cials including President, Speaker of the State Great Khural, Prime Minister, members of the Parliament and Government, Governors of aimags and the capital city, as well as their spouses, cohabitants, children and any related party will be prohibited from participating in any form of procurement activities funded by the Government, state-owned companies, and international organizations' projects and programs, jointly implemented by the Government during their tenure in office. Furthermore, they will be precluded from receiving any concessional loans, grants, or guarantees during their tenure in

office, as the draft law stipulates.

In addition to the officials mentioned above, the prohibition clauses apply to chairperson of political party which holds seats in the State Great Khural, members of the Constitutional Court, the Chief of Justice and judges of the Supreme Court, the State Prosecutor General, members of the Public Service Council, as well as heads and deputies of organizations that report to the Parliament and the Government,

including the Bank of Mongolia, the General Election Committee, and the Anti-Corruption Agency, the Central Intelligence Agency, National Police Department, Customs General Administration, National Emergency Management Agency, General Department of Taxation. Other agencies covered by the law include General Authority of State Registration, General Authority for Social Insurance, the Civil Aviation Authority and the Mineral Resources Authority.

Resources Authority.

"By passing this law, we will establish clear boundaries between politics and business marking the point of an ethical boundary where the state and business operate detachedly. I am confident that this law will serve to prevent and protect many politicians and public servants from potential corruption risks in the future. Going forward, we will engage in active public discussion to implement basic reforms for making public service efficient and "doing more with less" by transforming the recruitment of civil service, transferring state property and workforce to the private sector, and introducing a unified system for public servant salaries that is based on their productivity and results," said PM Oyun-Erdene.

Under the framework of the New Revival Policy, an anti-corruption legal reform has been launched and during this spring session of the State Great Khural the Law on the Legal Status of Whistleblowers, the Law on Judiciary, and the National Anti-Corruption Program and amendments to the Constitution, the Law on Regulation of Public and Private Interests in Public Service and the Prevention of Conflict of Interest, and the Code of Conduct for Public Servants are scheduled to be approved.

**High-Level Agreements to Boost Relations in New Era** 

Minister of Foreign Affairs of Mongolia Batmunkhiin Battsetseg paid a working visit to China on May 1-2, 2023 at the invitation of a member of the State Council and Minister of Foreign Affairs of the People's Republic of China Qin Gang.

-Foreign Minister, how would you define the purpose and the significance of your visit to the PRC?

One of the priority goals of our Government is to intensify cooperation in all sectors and at levels, and bolster our comprehensive strategic partnership after the pandemic with one of Mongolia's two neighbors, the PRC. The PRC has defined their new development goals and appointed a new generation of leaders at the 20th National Congress of the Communist Party of China in October, 2022, and its "Two Sessions" in March. 2023. The purpose of my visit was to promote bilateral relations and cooperation, and establish working relations with the PRC's new generation of leaders. During my working visit to Beijing on May 1-2, I met and held official talks with PRC State Councilor and Foreign Minister Oin Gang, and exchanged views on a wide range of issues regarding Mongolia-China relations, and reached concrete agreements, which asserted to the importance of the

It is important to maintain high-level mutual visits and meetings between our two countries, and both sides have been able to organize and maintain a frequency of such exchanges even during the difficult period of the pandemic.

One of the outcomes of my visit was that the two sides agreed to organize Prime Minister L.Oyun-Erdene's official visit to the PRC in the near future.

# the PRC in the near future. -What were the concrete issues that were agreed?

-President of Mongolia Ukhnaagiin Khurelsukh paid a state visit to the PRC in November 2022, during which he met with President Xi Jinping. Both sides reached an agreement at the highest level on issues such as promoting and developing bilateral relations and cooperation in the new era. In order to significantly contribute to the nation's development, we are mainly focusing on putting these agreements into action.

One of the priorities of Mongolia's foreign policy is to develop friendly relations with our two neighbors. China too attaches great importance to its relations and cooperation with Mongolia and considers Mongolia as its good neighbor, good friend and good partner. In this regard, the parties agreed to bolster political trust, mutually respect the fundamental interests of each other, and develop an ideal example of bilateral cooperation in the region.

The key area of Mongolia-China relations is cooperation in the field of trade, economy and investment. The goal is to increase trade between the two countries to USD 20 billion by 2027. Our bilateral trade reached



13.6 billion USD 2022, and USD 3.48 billion in the first quarter of this year.

During the meetings with the Chinese side issues such as increasing port capacity, and intensifying the works of connecting them by road and rail, which would facilitate the increase of trade volume were raised. For instance, outstanding issues such as revising the 1955 Railway Agreement, 2004 Agreement on Border Ports and their Regime, 2014 Agreement on Transit Transport, and adding Khangi-Mandal railway port into the Agreement on Border Ports, and accelerating the construction work of the railway at the Gashuunsukhait-Gantsmod border port were addressed.

-Since the beginning of this year, China began to ease the strict travel restrictions imposed during the pandemic and people have begun to travel again. The Government of Mongolia declared years 2023 through 2025 the "Years to Visit Mongolia." Was there any discussion and talks made on receiving tourists from China to Mongolia?

-In order for people to obtain positive and accurate informa-tion and understanding of each other's cultures, histories and livelihoods, we should encourage our people to travel and visit other's countries. The two sides have discussed and agreed to organize Mongolian-Chinese culture and tourism forum, to upgrade and improve the e-visa process for tourists, to increase number of direct flights and to make promotional materials on Mongolia available in Chinese in order to further promote tourism between the two countries. The land and air travel between the two countries have resumed to normal. The international passenger trains will resume its operation starting this month. Moreover, the Embassy of Mongolia to the People's Republic of China opened a new "Culture Center" this year, which aims to promote Mongolia in China, organizing many events and activities promoting Mongolia, especially to the children and vouth.

-Spring season is the time of the year when the yellow sandstorms start in Beijing. Nowadays, environmental cooperation is increasingly becoming one of the most important topics to be discussed among countries within the bilateral cooperation framework. Have you discussed this issue with the Chinese counterparts? What is the current progress of

## other development cooperation projects?

-Under the "One Billion Trees" National Campaign initiated by the President of Mongolia, a joint project to establish a "Research Center to Combat Desertification" is being implemented. China has an extensive experience in combating desertification and re-forestation efforts and therefore, has agreed to implement the abovementioned joint-project. Mongolia will be organizing the 17th Conference of the Parties (COP17) of the United Nations Convention to Combat Desertification (UNCCD) in 2026 and China has agreed to cooperate with us in this regard as well.

The grants and concessional loans provided by the Government of the People's Republic of China, significantly contribute in resolving pressing socio-economic issues in Mongolia. For instance, projects such as "Cen-Wastewater Treatment Plant of Ulaanbaatar City," "Erdene-buren Hydropower Plant," and Passageway' "Underground (which aims to reduce the Ulaanbaatar city traffic congestion) are being successfully implemented. In addition, the implementation of the joint-projects such as the 'Grand Theatre of National Arts' and the "Presidential Sports and Training Center for Children and which have been agreed upon during the President of Mongolia Mr. U. Khurelsukh's state visit to People's Republic of China, will commence this

-The PRC has become an active player on the international stage, and Chinese President Xi Jinping has announced three major initiatives: Global Security Initiative, Global Development Initiative, and Global Civilization Initiative. Does Mongolia support these initiatives?

-PRC President Xi Jinping proposed Global Development Initiative in 2019, the Global Security Initiative in 2022, and Global Civilization Initiative in 2023. These initiatives declare safeguarding humankind's secure and peaceful life, sustainable development, diversity of civilizations, and promoting international cooperation in this regard as their primary objective. These are in line with our country's foreign policy objectives and principles, and we are ready to exchange views and cooperate with the Chinese side in this direction.

Mongolia joined the Group of Friends to "Foster Global Development – Promote Stronger, Greener and Healthier Global Development for the 2030 Agenda for Sustainable Development," established by the PRC last year at the UN.

During the "Dialogue with

World Political Parties High-level Meeting" organized on March 15, PRC President Xi Jinping proposed the "Global Civilization Initiative," stating, "We advocate the respect for the diversity of civilizations. Countries need to uphold the principles of equality, mutual learning, dialogue, and tolerance. Countries need to keep an open mind in appreciating the perceptions of values by different civilizations and refrain from imposing their own values or models on others and from stoking ideological confrontation. Countries need to fully harness the relevance of their histories and cultures to the present times and push for creative transformation and innovative development of their fine traditional cultures. These statements are consistent, in essence, with Mongolia's foreign relations, policy, and objectives concerning cultural and humanitarian issues

-The value of civilization includes religious issues. These issues are also relevant to Mongolia-China relations. What is our official position on this matter?

-Religion is definitely a core value of culture. Mongolia and China are both Asian Buddhist countries. There have been cases in world history where religious issues have affected relations between countries. Our two countries have a comprehensive strategic partnership, and we have been able to reach a mutual understanding and resolve any conflicts through dialogue.

Our citizens' right to freedom of religion and expression is ensured and protected by law. Moreover, the state and religion shall conduct their activities separately and not interfere in each other's affairs as stipulated in the Constitution of Mongolia.

I would also like to emphasize that religious issues are subject to the internal affairs of both countries. Mongolia conducts its policies and activities on any religious issues independently and without external interference, as it should. We will independently resolve any religious matters, including identifying the head of traditional Buddhist in Mongolia, without any involvement from outside.

Nowadays, we have ample opportunity to train its lamas internally and enhance their capacities. This undoubtedly will help us pursue independent religious policy and develop Buddhism in Mongolia on our own.

# -During the visit were issues related to international relations discussed?

-Apart from issues of bilateral relations and cooperation, regional and international topics of mutual interests were also discussed. Within the framework of intensifying Mongolia-Russia-China trilateral cooperation, both sides agreed to renew the central railway corridor, accelerate the construction of the natural gas pipeline from Russia to China through Mongolia's territory, and the construction of the Altanbulag-Zamiin-Uud highway project.

#### -What are rights and duties of an owner of a certificate?

- -According to the Law on Electronic signature that has been in force since 1 May 2022, an owner of a certificate of an electronic signature certificate shall have the following rights:
- 1. Use digital signature and electronic seal;
- 2. Submit a request to suspend, restore and cancel a certificate;
- 3. Have his own personal key stored in the organization in the partial form;
- 4. Set limits in the use of the digital signature and electronic seal:
- 5. Other rights specified in the law.

The owner of a certificate of an electronic signature certificate shall have the following duties:

- 1. Not to assign/transfer the personal key to others;
- 2. Ensure confidentiality and safety of the personal key;
- 3. If other people have acknowledged about the personal key or there is a suspect of possibility to know it, the certificate issuing organization (or licensing organization) should immediately be informed of the fact;

  4. In a case of cancellation
- 4. In a case of cancellation of the certificate, not to use the personal key attached to the certificate;
- 5. Not to use the personal key for data authentication and confidentiality if the data is considered to be illegal;
- 6. Other duties specified in the law.

The owner of the certificate shall be for all consequences occurred due to the transfer of the personal key to others or disclosure of the confidentiality because of own wrong activities.

# -What are cases of cancellation of a certificate?

- -The certificate issuing organization (or licensing organization) shall cancel the certificate on the following grounds:
- on the following grounds:

  1. Valid period of the certificate is expired;
- 2. Submission of the request by the certificate owner on the reasons that the personal key has been disclosed, or conditions to be disclosed have been created;
- 3. Written request of the certificate owner to cancel the certificate;
- 4. In cases of death of the certificate owner, or the person has been deemed died, the organization has been dissolved;
- 5. In the case if it is proved that false documents were created when obtaining the certificate:
- when obtaining the certificate;
  6. The certificate owner did
  not perform duties specified in
  the law.

The fact that the certificate expiry date is not present does not affect the cancellation of the certificate.


#### Two Bronze Medals Secured at World Judo Championships
